



## MicroProbe Web Site Terms of Use

Last Updated on July 12, 2010

**IMPORTANT: PLEASE READ THESE TERMS OF USE (“TERMS”) CAREFULLY BEFORE USING THE WEB SITE OWNED AND OPERATED BY MICROPROBE, INC. (“MICROPROBE”) AT WWW.MICROPROBE.COM (THE “SITE”). BY ACCESSING AND USING THE SITE YOU ARE INDICATING THAT YOU ACCEPT, AND AGREE TO COMPLY WITH, THESE TERMS. IF YOU DO NOT ACCEPT THESE TERMS, YOU ARE NOT PERMITTED TO, AND YOU MUST NOT, ACCESS OR USE THE SITE.** The terms “you” and “your” for purposes of these Terms, means both you in your individual capacity, and the company or other business entity whom you represent and on whose behalf you use the Site under actual or apparent authority. **BY AGREEING TO THESE TERMS AND/OR USING THE SITE, YOU REPRESENT AND WARRANT THAT YOU HAVE THE AUTHORITY TO REPRESENT THE COMPANY OR BUSINESS ENTITY FOR WHOM YOU ARE ACTING.**

**Changes to Terms.** MicroProbe may add to, change or remove any part, term or condition of these Terms, and any Content (as defined below), including without limitation product and service descriptions and pricing, at any time without prior notice to you. It is your responsibility to check these Terms periodically for changes. By continuing to use access the Site, you are indicating your acceptance of such changes. We will notify you of significant changes to these Terms by changing the “Last Updated” date above.

**Privacy.** MicroProbe will only use any personal information that you provide to MicroProbe in connection with your use of the Site, in accordance with the terms of our privacy policy (the “**Privacy Policy**”). In this regard, you agree to the then-current version of the Privacy Policy that you can find and read at [www.microprobe.com](http://www.microprobe.com). You hereby agree that we may use your personal information in accordance with the terms of the Privacy Policy.

**Use of Site.** Subject to your compliance with these Terms, MicroProbe hereby grants you a limited, personal, revocable, non-transferable, non-sublicensable, and non-exclusive license to access the Site and use the information, text, images, graphics, user and visual interfaces, applications, software, documents, and other materials (collectively, the “**Content**”) displayed on the Site, solely for your personal internal business use, on condition that such use is solely in accordance with the purposes for which MicroProbe makes the Site and Content available. You may not copy, modify, reproduce, publicly display or perform, distribute, or otherwise use the Content except as expressly set forth above. You may not remove any copyright or other proprietary notices from any Content. **Prohibitions.** You hereby represent and warrant that you will not, and will not induce any third party to: (a) attempt to disable or circumvent any security mechanisms used by the Site or otherwise attempt to gain unauthorized access to any portion or feature of the Site or Content, or any other systems or networks connected to the Site, or to any MicroProbe server, by hacking, password “mining”, or any other

Notwithstanding the foregoing, MicroProbe may seek injunctive or other equitable relief in any court of competent jurisdiction to protect its proprietary and other rights. You agree that your breach or threatened breach of these Terms may result in immediate and irreparable damage to MicroProbe for which there is no adequate remedy at law. The failure of MicroProbe to exercise or enforce any right or provision of these Terms shall not constitute a waiver of such right or provision. If any part of these Terms is held invalid, illegal or unenforceable, that provision shall be enforced to the maximum extent permissible so as to maintain the intent of these Terms, and the other parts will remain in full force and effect. These Terms are only valid in the English language.
